

## **HAMLET OF REPULSE BAY BYLAW NUMBER 167**

A Bylaw of the Municipal Corporation of the Hamlet of Repulse Bay in the Nunavut Territory to provide for the payment of Honorariums and Allowances to Members of the Hamlet Council, pursuant to the provisions of the Hamlets Acts, S.N. 2003, c.3, s.34.

**AS** it is desirable to set rates of Honorariums and Allowances for Members of the Hamlet Council,

**NOW, THEREFORE, THE COUNCIL OF THE HAMLET OF REPULSE BAY**, at a duly assembled meeting, enacts as follows:

### **SHORT TITLE**

1. This Bylaw may be cited as the "**Council Indemnity Bylaw.**"

### **INTERPRETATION**

2. In this Bylaw:

**INDEMNITY**

3. Honorariums and Allowances are payable to Members of Council at the rates sets out in Schedule A, attached to and forming part of this Bylaw.

**REPEAL**

4. Bylaw Number 166 is hereby repealed.

**SCHEDULE A**

1. Annual Stipends are payable to the Members of Council as follows:

a) Mayor	Annual Stipend of \$47,000
b) Deputy Mayor	Annual Stipend of \$20,200
c) Councillors	Annual Stipend of \$ 8,600

Payments will be made bi-weekly.

2. Where the Mayor does not attend a Regular Meeting, \$500.00 will be deducted from the Annual Stipend payment, unless the Mayor is away on Hamlet business.

3. Where the Deputy Mayor does not attend a Regular Meeting, \$300.00 will be deducted from the Annual Stipend payment, unless the Deputy Mayor is away on Hamlet business.

4. Where a Councillor does not attend a Regular Meeting, \$150.00 will be deducted from the Annual Stipend payment, unless the Councillor is away on Hamlet business.

5. Council must hold at least one Regular Council Meeting per month.

6. At any meeting where a Councillor, other than the Mayor or Deputy Mayor, is required to Chair the Meeting in the Mayor's absence, that Councillor shall receive an Honorarium of \$300.00 for Chairing that meeting.

7. Where a Member of Council is required to conduct business on behalf of the Hamlet outside the municipality, an Allowance, not to exceed \$200.00 per day, may be paid to the Member of Council, if so authorized by resolution of Council, unless the Allowance is paid by a source other than the Hamlet.

8. When a Member of Council attends Special Meetings of Council and Meetings of Committees of Council, the Member of Council may receive an Honorarium of \$100.00 per meeting.
