By-law No. 230

A by-law of the Municipal Corporation of the Hamlet of Naujaat in the Nunavut Territory, to authorize a Reserve Fund, pursuant to the provisions of the Hamlets Act, R.S.N.W.T. 1988, c. H-1 as amended by S.Nu.2003, c.3. s.143.1 (1) & (2.a.b.c)


WHEREAS the Council of the Hamlet of Naujaat deems it to be in the best interests to segregate portions of the funds for a specific purpose;

NOW, THEREFORE, THE COUNCIL OF THE HAMLET OF Naujaat, in a meeting duly assembled, enacts as follows:

1. This by-law may be cited as the "Quarry Restoration Reserve Fund".
2. Where the quarry material has been removed from the designated quarry as per the Quarry Administration Agreement a Quarry Restoration Reserve Fund must be established to meet the requirements agreed upon to maintain and operate the quarry.
3. The Mayor and Senior Administrative Officer are hereby authorized to execute, on behalf of the Hamlet of Naujaat, the Quarry Restoration Reserve Fund referred for future restoration as per Schedule "A" – quarry fees and Schedule "B" Quarry Permit Application Form, attached to and forming part of this bylaw.





### **Commercial Fees**

Application Fee 1-year permit	\$150.00
Royalties on sand, gravel or loam	\$1.50/m <sup>3</sup>
Royalties on other material (i.e. Carving stone)	\$1.25/m <sup>3</sup>

### **Naujaat Resident**

10 cubic meters of loam; and	
40 cubic meters of sand, gravel or stone	FREE
