



HAMLET OF REPULSE BAY
BY-LAW NO. 9B

BEING A BY-LAW TO ESTABLISH LEVELS OF
SERVICE AND RATE FOR THE PROVISION OF WATER, SEWAGE AND
GARBAGE SERVICES, TIME AND PLACE OF PAYMENT.

PURSUANT TO SECTIONS 180 AND 181 OF THE MUNICIPAL ORDINANCE,
BEING CHAPTER M-15 OF THE REVISED ORDINANCES OF THE NORTHWEST
TERRITORIES (1974), THE COUNCIL OF THE HAMLET OF REPULSE BAY IN A
MEETING DULY ASSEMBLED, ENACTS AS FOLLOWS:

1. SHORT TITLE

This by-law may be cited as the MUNICIPAL SERVICE BY LAW.

2. HAMLET'S AUTHORITY

The delivery of drinkable water and the collection and disposal of sewage and garbage shall be the sole responsibility of HAMLET and may only be carried out under the HAMLET'S AUTHORITY.

3. LEVELS OF SERVICE

The levels of service to be provided under this by-law shall be as follows:

WATER DELIVERY – All water tanks will be filled on a regularly scheduled, house-by-house basis, 52 weeks a year. Emergency service will be available at anytime during the weekly published hours of service.

SEWAGE PUMPOUT – All sewage holding tanks will be pumped out on a regularly scheduled house-to house basis, 52 weeks a year. Emergency service will be available at anytime during the weekly published hours of service.

GARBAGE PICKUP – all household garbage will be picked up on a regularly basis, 52 weeks a year.

4. LIMITATIONS ON REGULARLY SCHEDULED SERVICE

THE HAMLET will make every effort to ensure that regularly scheduled service is provided to all community residents, weather, road and vehicle conditions permitting.

5. MUNICIPAL SERVICE RATES

The following rates will apply for the services provided under this BY-LAW:

- a.) For the houses managed by the REPULSE BAY HOUSING ASSOCIATION a FLAT MONTHLY RATE of \$225.00 per unit per month for water, sewage, and garbage.
- b.) For the GOVERNMENT OF THE NWT the following building 4 schools, and up to 6 staff houses. FLAT MONTHLY RATE of \$3,900.00 for water, sewage, garbage and snow removal as required.
- c.) For HUDSON'S BAY COMPANY store and residence a FLAT MONTHLY RATE of \$300.00 for water, sewage, garbage and snow removal as required.
- d.) For COFFEE SHOP a FLAT MONTHLY RATE of \$225.00 for water, sewage and garbage.
- e.) For R.C.M.P. TRAILER a FLAT MONTHLY RATE of \$150.00 for water, sewage and garbage.
- f.) For NAUJAT CO-OP the following building bunkhouse, store and residence a FLAT MONTHLY RATE of \$500.00 for water, sewage and garbage and snow removal.
- g.) For MEDICAL SERVICE a FLAT MONTHLY RATE of \$1,200.00 for water, sewage and garbage, and snow removal as required.
- h.) For AIVILIK LODGE (hotel) MONTHLY RATE of \$500.00
- i.) For PRIVATE HOMES (HAP) \$75.00 per month

6. PAYMENT OF SERVICE CHARGES

- a.) Invoices will be prepared and mailed by the HAMLET OFFICE staff at the beginning of each month for service provided during the previous month.
- b.) Payment is to be made by mailed or in person to the HAMLET OFFICE within 30 days of the mailing of the invoices may be suspended.

7. CONTRACTS

nothing in this BY-LAW precludes or prohibits the COUNCIL of the HAMLET of REPULSE BAY from entering into specific contracts with either individuals, companies or incorporated organizations for the provision of Municipal Services within REPULSE BAY.

8. COMING INTO FORCE

This BY-LAW shall come into force on the day that it is given third reading and passed.
